IMPORTANT EVENT TO BE REPORTED: Information on the litigation in contradiction with Novi Consult SRL, L + K Anlagenbau GMBH & CO.KG and Hatec Industrie - Montagen GMBH

The company Sinteza SA informs the shareholders and the investors, the interested public, about the stage of the file no. 5610/3/2017, having as its subject-matter claims.

As a result of Civil Sentinel no. 96/2019, issued by the Bihor Court in File 5610/3/2017, partially upholding the counter-claim made by NOVI CONSULT SRL and obliging SINTEZA SA to pay: the sum of 679,480.42 lei c / v letter of bank guarantee, related fees, legal costs amounting to 10,399.80 stamp tax, 500 lei expert fees, the amount of 137,818.88 lei lawyer fee, as well as to pay to L + K Anlagenbau GMBH and Hatec Industrie -Montagen of the amount of 273,281.04 lei lawyer fee, our company have formulated APPEAL within the legal term, appeal filed at the Registry of the Bihor Court on 27.05.2019
